ARTICLES OF INCORPORATION OF

SECRETARY OF STATE TALLAHASSEE. FLORIDA

COMMUNITY EDUCATIONAL OVERSIGHT CORP.

The undersigned acting as incorporators of a corporation pursuant to Florida Corporation Statute 617, adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

COMMUNITY EDUCATIONAL OVERSIGHT CORP.

ARTICLE III PRINCIPAL PLACE OF BUSINESS ADDRESS

ARTICLE III PURPOSES

- 1. To oversee all state legislation, policies, committees and other functions of the State of Florida educational system as an independent non-governmental entity serving the interests the community at large.
- 2. The presentation of educational seminars designed to inform the community about the structure of the State and local educational administrative agencies and how those entities function.
- 3. To educate the community at large on how to utilize the grievance procedures when there is dissatisfaction with educational services, administrative or individual teacher performance.

- 4. To operate exclusively for charitable, religious and educational purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or any corresponding provision of any future United States Internal Revenue Law.
- 5. To provide an on-going public forum to promote the creation of citizen communication networks designed to foster accountability relationships between schools officials and the community at large.
- 6. To create and promote the social welfare of the community and its youth through education as to how the state education system operates and how that system can function to stimulate positive change to revitalize educational growth.
- 7. To promote the social welfare and betterment of the community and its youth through the dissemination of information promoting programs for betterment of the day to day lives of community residents and the provision of workshops and literature to insure their maxium participation in decisions concerning the State of Florida school system.

ARTICLE IV DISSOLUTION

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors assets of the corporation shall be distributed to a non-profit 501 (c)(3) corporation. "However" if the named recipient is not in existence as a distributee, or unwilling to accept the distribution, the assets shall be distributed to a fund, or foundation, or organization which operates exclusively for purposes specified in section 501 (c)(3) of the United States Internal Code of 1986 or any corresponding provision of any future Internal Revenue Law.

ARTICLE V LIMITATION OF POWERS

Notwithstanding any other provision of these articles, the organization shall not carry on activities nor permitted to be carried on by an organization

exempt from federal income tax under section 501 (c) (3) of the United States Internal revenue Code of 1986 or any corresponding provision of any future Internal Renue Law.
