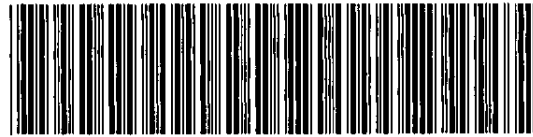

ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be:

Calvary Life Church, Inc

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose of which the corporation is organized is:

The corporation is organized exclusively for Calvary Life Church, charitable, educational, religious, or scientific purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

To transact any other lawful business for which not for profit corporations may be incorporated under Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with the foregoing process.

ARTICLE IV DISSOLUTION

Upon Dissolution of the corporation, The Board of Trustees shall after paying or making provisions for the payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization organizations under Section 501 (c) (3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law), as the Board of Trustees shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE V MANNER OF ELECTION:

Directors and Officers are elected annually by the members. Members shall be eligible for election to the Board of Directors as prescribed by the organization's By Laws, rules and regulations.
