**ARTICLES OF INCORPORATION  
OF  
STYLE SAVES INC.**

I, the undersigned natural person of the age of 21 years or more, with other persons being desirous of forming a not-for-profit corporation under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

**ARTICLE I**

**NAME**

The name of this corporation is Style Saves Inc. (the "Corporation").

**ARTICLE II**

**ADDRESS**

The address of the principal office and the mailing address of the Corporation is 1050 Brickell Avenue, #3220, Miami, Florida 33131.

**ARTICLE III**

**PURPOSE**

This Corporation is organized for the purpose of and shall operate exclusively for educational, cultural, charitable and scientific purposes and to make gifts, grants, loans and subsidies to other charitable and/or education organizations described in Section 501(c)(3) of the Internal Revenue Code, including but not limited to, connecting the community with our students, art and culture, giving a fresh start to students through fashion and building their confidence through clothes (including raising funds to provide high school students with a new outfit for the start of school). The purposes of the corporation shall, however, be limited in all events to exempt purposes described in Section 501(c)(3) of the Internal Revenue Code of 1986 as amended. Furthermore, this corporation may engage in only activities permitted under the laws of the State of Florida and the United States of America as shall constitute activities in furtherance of such exempt purposes. In furtherance of its exempt purposes, the corporation may promote, establish, conduct and maintain activities on its own behalf and it may contribute to or otherwise assist other corporations, organizations and institutions carrying on exempt activities.

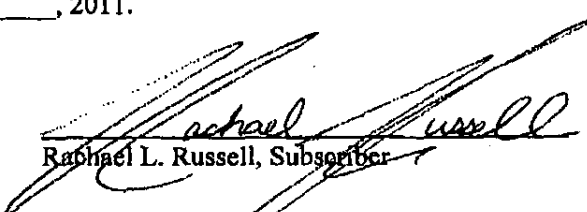
