

Article III. Purpose

Section 1

This corporation is organized and operated exclusively for charitable, educational, religious and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific purposes for which the corporation is formed are to:

- A) Promote and provide care, healthcare and educational support to the Haitian community in the United States.
- B) Promote the development of the "Department of Artibonite, Haiti, 2nd Section of the Commune of Anse-Rouge, (particularly: Coridon, Pointe-des-Mangles, Bonal, Carrenage, etc...)" by providing electricity, support in healthcare, education, sait farming, fishing and agriculture.

This corporation shall raise funds, including grant seeking, in order to achieve its purposes. This corporation shall also procure and acquire, by donation, purchase, lease or otherwise, and hold control to the above mentioned assets, as may be beneficial to the fulfillment of the charitable, educational, religious and scientific purposes of LA FONDATION LESAGE, INC.

Section 2

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible

under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

"Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."

Section 3

Upon the dissolution or winding up of the corporation, assets, remaining after payment, or provision for payment, of all debts and liabilities of this corporation, shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article VIII. Term of Existence

This corporation shall have perpetual existence.

Article IV. Effective Date

This Articles of Incorporation shall be effective on <u>February 25th, 2011</u> upon approval of the Secretary of State, Sate of Florida.
