

## ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)



#### ARTICLE I NAME

The name of the corporation shall be:

SELAH CHRISTIAN COMMUNITY CENTER, INC.

#### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

#### ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

This Corporation is organized and shall be operated as a faith-based nonprofit corporation solely and exclusively for religious, charitable, educational, scientific, and literary purposes, including for such purposes, the making of distribution to organizations that qualify as exempt organizations under section 501(c)3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, and specifically those purposes identified in the corporation bylaws; however, the Corporation shall not perform any act or transact any business that will jeopardize the tax exempt status of the Corporation under Section 501(c)3 of the Internal Revenue Code and its regulations, as such Section and regulations now exist or may hereafter be amended or revised under corresponding laws and regulations hereafter adopted.

Upon the dissolution of Selah Christian Community Center, Inc, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for a public purpose.

Notwithstanding any other provision of these Articles, Selah Christian Community Center, Inc. will not carry on any other activities not permitted to be carried on by an Organization exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law.

ARTICLE IV MANNER OF ELECTION The manner in which the directors are elected or appointed:

The initial corporation Directors shall be appointed by the Incorporator until such time that a meeting is held to appoint new and/or increase the number of Directors. The business of the Corporation shall be managed by the Board of Directors. The Board of Directors shall be elected and hold office in accordance with the bylaws. The Officers of the Corporation shall consist of a President, Vice President, Secretary, and Treasurer and such other Officers as may be provided in the Bylaws.
