ARTICLE I

The name of this corporation shall be **River Oaks Community Church, INC.**

ARTICLE II

The initial principal office of this corporation shall be 208 Argonaut Rd, St. Augustine, FL 32086. The initial mailing address of this corporation shall be the same.

ARTICLE III

This Statement of Faith of the corporation may be changed from time to time and as set forth herein:

1. We believe the Bible is the written word of God, inspired by the Holy Spirit and without error in the original manuscripts. The Bible is the revelation of God's truth and is infallible and authoritative in all matters of faith and practice.
2. We believe in the Holy Trinity. There is one God, who exists eternally in three persons: the Father, the Son, and the Holy Spirit.
3. We believe that all are sinners and totally unable to save themselves from God's displeasure, except by His mercy.
4. We believe that salvation is by God alone as He sovereignly chooses those He will save. We believe His choice is based on His grace, not on any human individual merit, or foreseen faith.
5. We believe that Jesus Christ is the eternal Son of God, who through His perfect life and sacrificial death atoned for the sins of all who will trust in Him, alone, for salvation.
6. We believe that God is gracious and faithful to His people not simply as individuals but as families in successive generations according to His Covenant promises.
7. We believe that the Holy Spirit indwells God's people and gives them the strength and wisdom to trust Christ and follow Him.
8. We believe that Jesus will return, bodily and visibly, to judge all mankind and to receive His people to Himself.
9. We believe that all aspects of our lives are to be lived to the glory of God under the Lordship of Jesus Christ.

#### ARTICLE IV

The corporation is organized exclusively for religious, charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. More specifically, the corporation is organized for the purpose of forming, maintaining, and operating a church.

#### ARTICLE V

This is a corporation not for profit organized under the laws of the State of Florida pursuant to Chapter 617, Florida Statutes.

1. Upon dissolution of this corporation, the Board of Directors shall, after paying or making provisions for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation and in such manner, or to such organization or organizations organized and operated exclusively for religious, charitable, or educational purposes as shall at the time qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code as it now exists or may hereafter be amended, as the Board of Directors shall determine. Such assets shall be distributed to the following organization if it qualifies as an exempt organization: Covenant Theological Seminary, St. Louis, Missouri or any other exempt organization that shall exist for the furtherance of the Christian faith. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
2. No part of the income or net earnings of this corporation shall be distributable to its members, directors or officers.
3. Notwithstanding any other provisions of these Articles of Incorporation, no member, director, officer, employee or representative of this corporation shall take any action or carry on any activities by or on behalf of the corporation not permitted to be carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or may hereafter be amended, or which are not permitted to be taken or carried on by an organization, the contributions to which are deductible under Section 170(c)(2) of such Code of Regulations as they now exist or as they may hereafter be amended.

#### ARTICLE VI

The corporation shall receive as members those who profess Jesus Christ as their Savior, manifest the fruits of the Spirit in their lives, and agree with the Statement of Faith and polity of the Corporation. The Bylaws of the Corporation may set forth terms and conditions regarding qualification, admission, termination, and standing of membership.

Amendments to these Articles of Incorporation may be made and adopted only by a vote of at least two thirds (2/3) of the members of the Board of Directors of the corporation.


