## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

COMMUNITY FOUNDATION FOR OCALA/MARION COUNTY, INC.

(A Florida Not-For-Profit Corporation)

Pursuant to the provisions of the Florida Not-For-Profit Corporation Act, codified in Chapter 617 of the Florida Statutes, Community Foundation for Ocala/Marion County, Inc. executes the following Articles of Amendment to its Articles of Incorporation:

1. Name. The name of the Corporation is:

A Florida Not-For-Profit Corporation

- 2. Amendment. The provisions of Article II, of the Articles of Incorporation of the Corporation are hereby supplemented to include the following additional Section 2.4:
  - 2.4 Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to the Federal Government, or to a State or Local Government, for a public purpose. Any such assets not disposed of shall be disposed of by the Circuit Court of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organizational or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
- 3. Members. The Corporation does not have Members, and therefore has not had Members entitled to vote on this Amendment.
- 4. Adoption. This Amendment to the Articles of Incorporation of the Corporation was adopted by the Board of Directors of the Corporation by execution of a Written Action of the Board of Directors dated 5-27-//\_.
