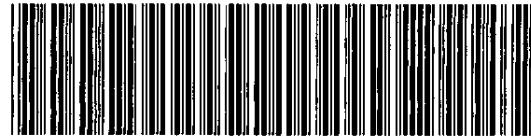



Florida Non Profit Corporation

The undersigned subscriber and or Incorporator to these Articles of Incorporation is a natural person. Competent and authorized to these articles of Incorporation for in the Beginning Pentecostal International Ministries, Inc., a Non-Profit Corporation under chapter 617 of Florida Statutes.

ARTICLE 1- Name

The name of this Corporation shall be: In The Beginning Pentecostal International Ministries, Inc, (hereinafter "Corporation.")

Articles 2- Purpose of the Corporation

A-Said corporation is organized exclusively for educational, charitable, religious, and Scientific purposes, including, for such purposes, the making of distributions organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

B-The specific and primary purposes for which this corporation is formed is to:

To provide for the instruction of individuals for the purposes of improving or developing their capabilities, or the instruction of the public on subjects useful to individuals and beneficial to the community, promote community service volunteer work intended to benefit the poor, distressed, or underprivileged, improve the moral, educational, religious, and social welfare of individuals, provide child day care, crime prevention, after school programs, out of school programs, and summer camp learning and recreational and services for youth, offer museum exhibits, as well as, cultural and artistic services and programs that enhances the development and demonstrate the talent of children, conduct school readiness assessments and evaluation that reflect the preschool progress in the areas of feeling, self-work, social skills, discovery skills, awareness of what goes on in immediate environment, interest in events large and small, creativity and imagination, flexibility, self care and safety, discipline and control, language skills and general physical health, and improve the quality of family and neighborhood life.

C-To provide tutoring services for the before and after school children.

D-To provide a school of the arts, drama, dancing, music and speaking lessons.

E-To help promote a community awareness concerning the importance of us pulling together to help our children to become better children and better students in school.

F-To offer our services to the parents in the community for family counseling support group for the single parent, and to help their cope with the day to day problems they may be experiencing with their children,.

G-To provide a mentoring program for children that need the enter acting of another person as a big brother or a big sister. So they would have someone they could talk to about their problems at home or at school are any other problems they may be facing their life.

H-To help the parent with planning and better Nutrition for their child. To help them understand the important of proper nutrition. How it is importance to the growth of the child. And how it helps with the development of the body and the mind.

To promote health awareness classes or the parents in our community. To help they understand the importance of their child physical records and immunization shorts. To help them to understand about HIV.

I-To offer parenting classes and stress relief programs for the parent who is having a problem parenting their child. Teaching them how to relief their anxiety and not taking it out on their child.

J-To be there for the child and the parent in any way we can to help them get along and to promote family unity. In the home with the mother and father with their child or children.

Article 3- Prohibitions

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, board of directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article second hereof.

No substantial part of the activities of the corporation shall be carrying on of Propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of Statements) any political campaign on behalf of or in opposition to any candidate for public office, Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal revenue Code, or the corresponding section any future federal tax code.

Article 4- Capital Stock

The Corporation shall have no capital stock and shall be composed of members rather than shareholders.

Articles 5- Qualification of Members And Manner of Their Admission

The categories of membership, qualification for membership and the manner of Admission shall be as forth in and regulated by the By Laws of the Corporation.

Articles 6- Voting Rights

Members of the Corporation will have voting as provided in the By-Laws of the Corporation.

Articles 7- Limitation of Corporate Powers

The corporate powers of this corporation are as provide in section 617 0302, Florida State.

Articles 8- Term of Existence

The corporation shall have perpetual existence.

Articles 9- Manner of Election of Directors

The Directors of the Corporation shall be elected by a majority vote of the members of the Corporation. Except for the President/ CEO (Chief Executive Officer), all Officers of the Corporation shall be appointed annually by a majority vote of the Board of Directors/ Trustees. The President/ CEO perpetually, as further described by the By Laws.

Articles 10- Officers

Articles 12- Board of Trustees/ Directors

Articles 13-Liabilities for Debts

Neither the members nor the members of the Board of the Trustees/Directors or Officers of the Corporation shall be liable for the debts of the Corporation.

Articles 14- Indemnification

The Corporation shall indemnify a director/trustee or officer of the Corporation who was wholly successful, on the merits or otherwise, in the defense of any? Proceeding to which the director or officer was a party because the director/Trustee or officer is or was a director/trustee or officer of the Corporation against reasonable attorney fees and expenses incurred by the director or officer in connection with the proceeding. The Corporation may indemnify an individual made a party to a proceeding because the individual is or was a director, trustee, Officer, employee or agent of the Corporation against liability if authorized in the specific case after determination, in the manner required by the board of directors, that indemnification of the director, officer, employee or agent, as the case may be, is permissible in the circumstances because the director,

trustee, officer, employee or agent has met the standard of conduct set forth by the board of directors. The indemnification and advancement of attorney fees and expenses for directors, trustees, officers, employees and agents of the Corporation shall apply when such persons are serving at the Corporation's request while a director, trustee, officer, employee or agent of the Corporation, as the case may be as a director, officer, partner, trustee, employee, or agent, of another foreign or Domestic Corporation, partnership, joint venture, trusts, employee benefit plan or other enterprise,. Whether or not for profit, as well as in their in their official capacity with the Corporation?

The Corporation also may also purchase and maintain insurance on behalf of an individual arising from the individual's status as a director, trustee, officer, employee or agent of the Corporation, whether or not the Corporation would have power to indemnify the individual against the same liability under the law. All references in these Articles of incorporation to "director", " trustee", " officer", " employee" and " agent" shall include the theirs, estates, executors, administrators and personal representative of such person

Articles 15- Amendment to the Articles or Incorporation

Except for Article 9 of these Articles of Incorporation, the Corporation may amend any of the other articles in the articles of Incorporation may be amended in the manner provided by law. 
Articles 20- Dissolution


