Article 1

The name of the corporation is COMMUNITY NET VISION, INC.

Article 2

The principle place of business of this corporation is 10033 64TH AVENUE NORTH #2-23, ST. PETERSBURG, FLORIDA 33708. The mailing address is P. O. BOX 86255, ST. PETERSBURG, FLORIDA 33708

Article 3

The corporation is organized exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law) including, but not limited to, for such purposes, the collection, preservation, and presentation of historic and recorded music; the educating of the public through its archives, public programs, and online access to its resources; and to engage in any other activity not prohibited to corporations under the Florida Not-For-Profit Corporation Act that is in furtherance of Section 501(c)(3) tax-exempt purposes.
