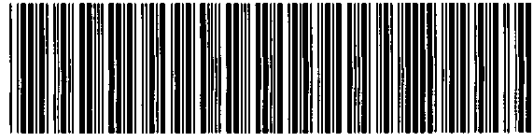

ARTICLES OF INCORPORATION OF
DIVAS & GENTS ON THE MOVE INTERNATIONAL, INC.

A Florida Non-Profit Corporation

ARTICLE I

The name of this corporation is DIVAS & GENTS on the Move International, Inc.

ARTICLE II

The county in the state of Florida where the principal office for the transaction of business of this corporation is to be located in Leon County.

The principal place of business and the mailing address of this corporation is: 720 Fairbanks Ferry Road, Tallahassee, Florida 32312.

ARTICLE III

The specific and primary purpose for which this corporation is formed is to operate for the advancement of charity and for other charitable purposes, by the distribution of its funds for such purposes, and particularly to bring together women of diverse backgrounds fostering an opportunity for them to grow spiritually, emotionally, physically, mentally, socially and financially. Chapter members will mentor young women and also communicate, coordinate, collaborate, and coordinate with men to form gentlemen chapters.

The general purposes for which this corporation is formed are to operate exclusively for such charitable purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provisions or corresponding provisions of any subsequent federal tax laws, including, for such

purposes the making of distributions to organizations which qualify as tax-exempt organizations under that Code.

This corporation shall not, as a substantial part of activities, carry on propaganda or otherwise attempt to influence, legislation; nor shall it participate or intervene (by publication or distribution of any statement or otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE IV

Board of Directors will be appointed as specified in the Corporation By-laws

ARTICLE V

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by board of directories. The number of directories of this corporation shall be 3, however, that such number may be changed by a by-law duly adopted by the members. method of collection thereof, shall be set forth in the by-laws.
