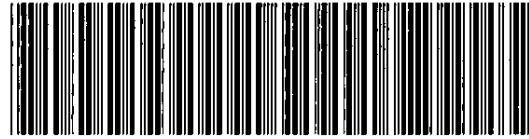

are organized and operated exclusively for such purposes.


