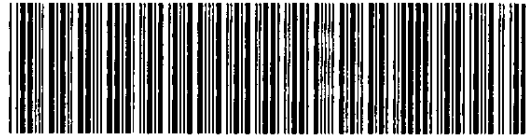

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of The International Bridge of Hope Foundation, Inc., do hereby certify:

ARTICLE I. Name

The name of this organization shall be The International Bridge of Hope Foundation, Inc.

ARTICLE II. Principle Office

The principal office and mailing address shall be 4930 Hernandez Drive, Orlando, FL 32808.

ARTICLE III. Mission and Purpose

The mission of The International Bridge of Hope Foundation, Inc. shall be to globally uplift and improve the lives of individuals and communities of people living in lower socioeconomic statuses or the less fortunate through education, health, and spirituality by empowering them with resources and the tools of self improvement.

The purpose of The International Bridge of Hope Foundation, Inc. shall be to strive in realizing our vision of a place where all children have a fair start in life and people globally have proper education, access to standard healthcare and a personal relationship with God.

All programming will reflect the Four Pillars of Hope. The Four Pillars of Hope is as follows:

1. Health
2. Education
3. Community
4. Faith

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV. Initial Directors and/or Officers

The affairs of The Bridge of Hope Foundation, Inc. shall be managed by the Board of Directors and the officers, which officers shall be the President, Treasurer (Chief Financial Officer) and Secretary (Clerk), the same being duly elected pursuant to the Bylaws at the annual meeting.

ARTICLE V.

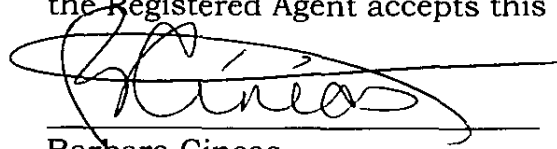
No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VI.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VII. Initial Registered Agent and Street Address

the Registered Agent accepts this designation.

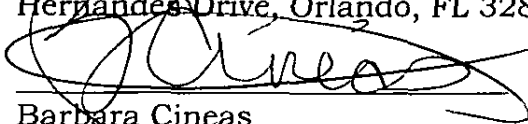
