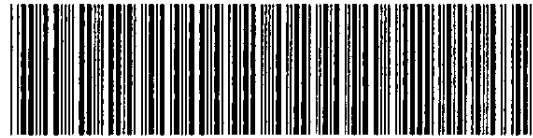

ARTICLES OF INCORPORATION

OF

SURFSIDE RESIDENTS ASSOCIATION, INC.

I.

The name of this corporation is Surfside Residents Association, Inc.

II.

The term for which this corporation shall exist shall be perpetual.

III.

The general nature of the business or businesses to be transacted by said corporation shall be as follows:

To serve as an organization of residents of the community of Surfside, Florida, and to represent their interests in having a properly operated, efficient, and productive local government; to advocate for the best interests of local citizens; to provide information to the community; to work for fair tax and fee rates; to protect the community through public interest zoning laws and policies; to seek reductions and eliminations of unnecessary and excessive town spending; to facilitate the residents of the community having a voice on important zoning and fiscal matters; to seek to restore open, honest and transparent government and official communications; to seek open public records and information in the public interest; and to generally serve, promote and facilitate having an open and honorable town government that serves the people rather than special interests which seek to profit at the expense of the public.

That of engaging in any activity permitted under the laws of the United States of America, its territories, districts, and possessions, and any activity permitted under the laws of the State of Florida, and to have, exercise, and enjoy the powers and privileges granted to corporations not for profit by Chapter 617, Florida Statutes.

To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes, of the attainment of any of the objects, or for the furtherance of the powers herein set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid business or powers, or any part thereof; provided, that the same be not inconsistent with the laws under which this corporation is organized.

The purposes for which the Surfside Residents Association, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

IV.

Officers/Directors shall be qualified for admission, and shall be admitted as Officers/Directors, in accordance with the by-laws of this corporation; a majority vote of the membership shall be required for the election of new Officers/Directors or for the removal of current directors.

V.

The street address of the initial registered office of this corporation is: 9032 Garland Avenue, Surfside, Florida 33154, and the initial registered agent at that address is: **Orestes Jimenez.**

VI.

This corporation shall have as directors initially those persons designated in this Article below. The number of directors may be either increased or decreased from time to time by the By-Laws, but shall never be less than three (3) nor more than five (6). 




