ARTICLE III A Tax-exempt Provision

The purpose of the tax-exempt provision is to provide explanation in the cause of Dissolution:

3A:01 <u>Private Inurement</u> - No part of the net earnings of the Ministry shall inure to the benefit of, or be distributable to its members, Board of Directors, officers, or other private persons, except that the Ministry shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

3A:02 <u>Ministry Properties</u> – All properties are the property of the Ministry and are not individually owned, but are irrevocably devoted to Ministry work.

3A:03 <u>Political Involvement</u> — No substantial part of the activities of the Ministry shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Ministry shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

3A:04 Operating as a 501 (C) (3) Entity — Notwithstanding any other provision of this document, the Ministry shall not carry on any other activities not permitted to be carried on (a) by a Ministry (church) exempt from federal income tax under section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a Ministry (church), contributions to which are deductible under Internal Revenue Code, or corresponding section of any future federal tax code.

3A:05 <u>Racial Nondiscrimination</u> – The Ministry shall have a racially nondiscriminatory policy and, therefore, shall not discriminate against members, applicants, students, and others on the basis of age, race, color, or national or ethnic origin.

3A:06 In the Event of Dissolution – In the event of dissolution of the Ministry, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the Ministry, dispose of all the assets of the Ministry to one or more church(es) or religious organization(s) as determined by the Board of Directors of this Ministry whose purposes are in harmony with the Full Gospel Message as outlined in Ministry's Articles of Faith. Such organization(s) must be organized and operated exclusively for religious purposes as specified in 501 (C) (3) of the Internal Revenue Code.
