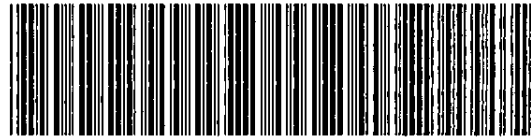

ARTICLE I - NAME

The name of the corporation shall be **NEUROGENESIS RESEARCH FOUNDATION, INC.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be **1610 Southern Blvd., West Palm Beach, FL 33406.**

ARTICLE III - PURPOSE

Said corporation is organized exclusively for charitable, educational, religious and scientific purposes. This includes paying for research to organizations and individuals that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The corporation will also support research, clinical trials and long term studies in the area of Neurogenesis. The focus of the initial research will include stem cells and natural substance's research. The main purpose will be to find a method to regenerate neuron producing cells in the human body primarily the brain.

The primary beneficiary of the corporations endeavors will be research groups engaged in this area of medicine. The ultimate beneficiaries will be individuals with neurological diseases, illnesses, or conditions without regard to sex, color, creed, or national origin who will finally have a cure for various neurological diseases.

**ARTICLE IV - INITIAL DIRECTORS
AND MANNER OF ELECTION**

The names and addresses of the persons who are the initial directors of the corporation are as follows. The initial each shall serve is also specified below. Elections shall be held on the 30th of April each year and two additional directors shall be elected at that time for a term of on year. Directors shall be five in number and three directors shall be elected to a two year term and two directors elected to a one year term. The directors shall be elected by the general membership of the Foundation.

ARTICLE V - FUNDS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set fo

rth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributpublic office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VI - DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
