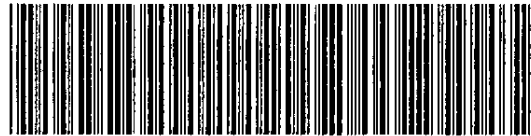

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I _____ Name

The name of the Corporation shall be Kehillah Chadashah, Inc. and shall have perpetual existence.

Article II _____ Principal Office

Article III ____ Purpose

- 3.1 The purpose of this institution shall be to conduct worship of God in accordance with the faith of Reconstructionist Judaism; to cultivate love for and understanding of the Jewish heritage; to stimulate fellowship in Jewish people everywhere; to fulfill all possible: Jewish religious and educational needs of its membership; and to be a community based on principles of personal participation in and commitment to study of Torah in all its aspects, and of observance of Judaism as a way of life.
- 3.2 The Corporation is organized and shall be operated exclusively for charitable, educational and scientific purposes under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and the Treasury Regulations issued thereunder, or the corresponding provisions of any future United States Revenue Law (the "Code").

Article IV _____ Directors

The corporation shall have no less than 9 directors. The manner of election or appointment, the qualifications and the term of directors shall be as set forth in the bylaws of the corporation adopted by the directors.

- distributed to another Reconstructionist Congregation in Florida or to the Jewish Reconstructionist Federation.
