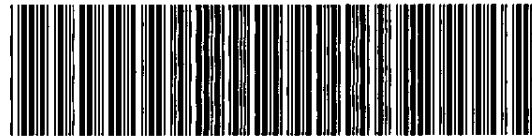

Pursuant to the provisions of section 617.1006, Florida Statutes, this **Florida Not For Profit Corporation** adopts the following amendment(s) to its Articles of Incorporation:

AMENDMENT ADOPTED TO ARTICLE III:

The correct Purpose for this business should be:

1- This corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes within the meaning of Section §501(c)(3) of the Internal revenue Service Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue Law. Specifically, but not limited, this corporation will be involved in preaching the gospel, helping the community in family relations, helping the woman in distress, helping children from dysfunctional families, and promoting good relationships.

2- In addition we will provide for those in need of restoration and mercies, the preaching and dissemination of the gospel of Jesus Christ and the word of God, through churches, schools, woman center, shelters, prison, adult care centers, hospitals, and other ministries.

3- We also will Foster and promote in the areas of economic well-being, social relationships, intellectuals achievements, physical improvement and spiritual development and growth for the purpose of enabling mankind of all ages and races, regardless of the status of each individual, to form a more realistic attitude and approach to God as the Father and creator of all things and the continues improvement in the relationships of human being among themselves.

4- To support and encourage communication and extension of the Christian life and witness by sound and comprehensive preaching and teaching of the Holy Bible of the Lord Jesus Christ to all men, both within this fellowship and


