## ARTICLES OF INCORPORATION

### Article I. Name

The name of this Florida not-for-profit corporation is:

### Article II. Address

### Article III. Purpose

The Corporation is organized exclusively to engage in all lawful acts or activities for which Florida not-for-profit corporations may be organized, including operating exclusively as a political campaign in accordance with the Florida Election Code, as now in effect or as may after be amended. In furtherance of this purpose, the nonprofit corporation may receive property by gift, devise or bequest, invest or reinvest same, and apply the principal and income thereof, as the Board of Directors may from time to time determine.

In furtherance of this purpose, the nonprofit corporation shall have all of the powers granted by the Florida Not For Profit Corporation Act, or any other relevant law, as now in effect or as may be amended, together with the power to solicit contributions for its corporate purpose.

This entity shall not carry on or conduct activity not permitted to be carried on by a nonprofit corporation exempt from federal income tax under Section 527 of the Internal Revenue Code, as now in effect or as may be amended.

### Article IV. Board of Directors

The affairs of the Corporation shall be managed by a Board of Directors consisting of no less than three directors. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of the Corporation, but may never be less than three. The election of directors shall be done in accordance with the Bylaws. The directors shall be protected from personal liability to the fullest extent permitted by law.

#### **Article V. Membership**

This nonprofit corporation does not have members.

#### **Article VI. Limitations**

No part of the net earnings of the Corporation shall inure to the benefit of (or be distributable to) its directors, officers, members or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes.
