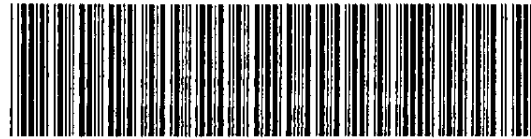

Of
Hope Hospice and Adult Day Care, Inc.**

Article 1.

The name of the corporation is Hope Hospice and Adult Day Care, Inc. effective as of this 8th day of March, 2011, by between and among the undersigned and confirms our understanding as to the matters herein.

Article 2.

The street address of the registered office is 1560 Roberts Drive Jacksonville Beach, Florida 32250-3222. Registered agent and such as addressed is Valencia Johnson-Flegler. The county of the registered office is Duval. Notwithstanding any other provisions of these articles, this corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501c (3) of the Internal Revenue Code of 1986 or corresponding provision of any future United State Internal Revenue law.

Article 3.

The purposes are organized pursuant to the Florida Non-Profit Corporation Code. The purposes of which the corporation is organized are exclusively religious charitable, educational, within the meaning of section 501c (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt as organizations described in section 501(3) and 170 c(2) of the internal revenue code of 1986 or corresponding sections of any prior or future in Internal Revenue Code, or to the state or local government for exclusive public purpose.

Article 4.

The manners of which the directors are elected are in our annual meetings held by the Board of Directors. In the event that the Board of Directors fails to so determine a date, a time, and a place of the meeting, it will be held at our annual meeting December 1. A special meeting of the Board of Directors may be called to appoint new officers, such requests shall state the purpose of the proposed meeting.
