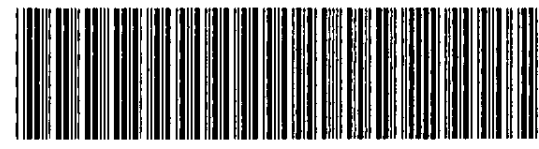

ARTICLE IName

The name of the Company is Rags to Riches Ministries, Inc.

ARTICLE IIPlace

The principle place of business is at 485 Meander Lane, Cantonment, Florida 32533, County of Escambia. This is the principle mailing address for the new corporation.

ARTICLE IIIPurpose
