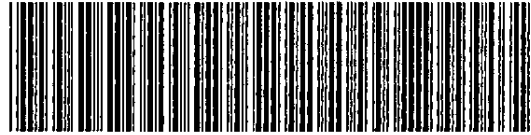

The specific purpose of this is nor for/ profit corporation is for the charitable religious and educational training purpose in Section 501(C).3 of the Internal Revenue Code 1986 and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not for Corporation may organized so for as or may be permitted by law of the state of Florida and the Section 501 (C) 3 of the Internal Revenue Code 1986 as mended . Article VIII

Notwithstanding any other provision of these articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501 (C) 3 of the Internal Revenue Code 1986 , as amended (or the corresponding provision of any future United States Internal Revenue Law) or (by) the corporation, contributions to which are deductible under Section 170(c) 2 of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United State Internal Revenue Law).
