



This Plan of Distribution of Assets of A BEKA TESTING, INC, a Florida corporation not for profit (the "Corporation") shall become effective as of the date the Board of Directors of the Corporation approves and adopts it in accordance with Section 617.1406 of the Florida Not For Profit Corporation Act ("Act").

1. All liabilities and obligations of the Corporation have been paid and discharged, or adequate provision has been made therefor.
2. Except as expressly provided for in this Plan of Distribution of Assets, no assets are held by the Corporation upon any condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution of the Corporation.
3. Except as expressly provided for in this Plan of Distribution of Assets, no assets have been received and held by the Corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes (but not held upon a condition requiring return, transfer, or conveyance by reason of the Corporation's dissolution), which assets must be transferred or conveyed to one or more domestic or foreign corporations, trusts, societies, or organizations engaged in activities substantially similar to those of the Corporation.
4. In accordance with the Corporation's Articles of Incorporation, upon dissolution of the Corporation, the Directors shall, after paying all obligations of the Corporation and all of the costs and expenses of the dissolution, distribute all remaining residual assets of the Corporation to Pensacola Christian College, Inc., a Florida corporation not for profit.
5. Except as expressly provided for in this Plan of Distribution of Assets, there are no other assets to be distributed in accordance with the provisions of the Corporation's Articles of Incorporation or Bylaws.
6. No assets remain for distribution to any other person, trust, society, organization, or domestic or foreign corporation, whether for profit or not for profit.




