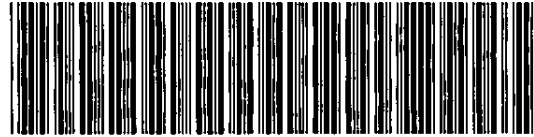


Please amend Article 3 Purpose to read as follows:
