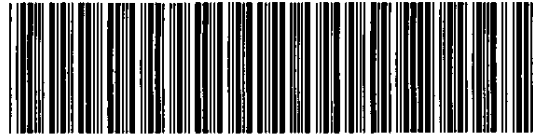

**Article III - Purpose**

Organized exclusively for charitable, religious, educational, and scientific purposes,  
including for such purposes, the making of distributions to organizations that qualify as  
exempt organizations under section 501c3 of the Internal Revenue Code, or

shall be distributed in accordance with the organization's by-laws and for one or more

said Court shall determine, which are organized and operated exclusively for such purposes.
