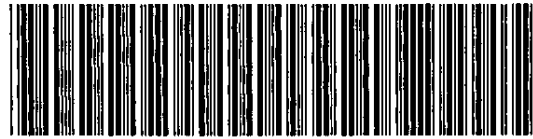

Article II. Purpose For Which The Corporation Is Organized And Powers

The purpose for which the corporation is organized is exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The specific purpose for which the corporation is organized is charitable and to foster national amateur triathlon sports competition, and no part of its activities involve the provision of athletic facilities or equipment. This corporation shall have the power to borrow money, to buy, own, lease, hold, sell, mortgage, and otherwise dispose of both real and personal property, and may hold the same by trustee or otherwise; to hold stock or bonds of other corporations and exercise all rights of ownership therein; and to have and use all other powers possible to be lawfully granted to it under the laws of State of Florida.
