

## Articles Of Incorporation Of THE MAR 24 PM 3: 45 INNER-CITY HARVEST INTL MINISTRIES NETWORK, INC. A NONPROFIT CORPORATION TALLAHASSEE FLORING

The undersigned, natural person of the age of eighteen years or older, acting as incorporator for the purpose of creating a nonprofit corporation under the laws of the State of Florida in compliance with Chapter 617, F.S., do hereby set forth:
