# Attachment to Articles of Incorporation of Angelwink Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To ensure that all veterans get to choose whatever college they want to attend. To provide financial aid during the most important time in a veteran's education. The first two months before a veteran goes to college the soldier is in need of financial aid. There is no aid that goes out to the student until 2 months after the student attends class. They are in need of books, rent, and etc. items that they may need during there move to a new city, coming back from war overseas and etc. If a soldier does not have private financial aid backing then they without the support necessary to attend the first year of college education.
