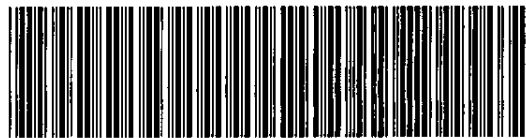

organizations, as said Court shall determine, which are organized and operated exclusively  
for such purposes.
