Articles of Incorporation

In compliance with Chapter 617, F. S. (Not For Profit)
Articles III Purpose

The purposes for which the corporation is organized includes, providing a Christian education school to the community, serving grades kindergarten through 12th with the main focus on special needs students.

Also, providing other educational services to include academic testing, tutoring, before and after school care, and summer school.

The purpose is to engaged in business as a Christian, school a non profit organization providing religious, charitable and educational services to individuals and the community.

Including performing, implementing of educational programs. To operate as a 501 (c) 3 organization. Including the following purposes:

- (a) Said organization is organized exclusively for charitable, religious, and educational, purposes, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code.
- (b) No part of the net earning of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the organization shall authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause here of, No substantial part of the activities of the organization shall be carrying on of propaganda, or other wise attempting to influence legislation, and the organization shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Articles of Incorporation

In compliance with Chapter 617, F. S. (Not For Profit)

Articles III Purpose

Notwithstanding any other provision of this document. The organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue code corresponding section of any future federal tax code, or(b) by an organization, contributions to which are deductible Under section 170(c) (2) of the Internal Revenue code, or corresponding section of any future federal tax code.

c) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of 501 (c) (3) of the Internal Revenue or corresponding section of any future federal tax code, or shall be distributed to the federal government, or a state or local Government for public purpose. Any such assets not disposed of shall be by the Court of Common Pleas of the County in which the principal office or the organization is located, exclusively for such purposes or to such organization as said Court shall determine, which are organized and operated exclusively for such purposes.
