





ARTICLES OF INCORPORATION SOUL WINNING FOR CHRIST MINISTRIES, INC. A FLORIDA NOT – FOR – PROFIT CORPORATION

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, acting as the incorporator of a not for profit corporation under
The Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statues, as
Amended, adopts the following Articles of Incorporation for such Corporation:

ARTICLE I: NAME

The name of the Corporation shall be: SOUL WINNING FOR CHRIST MINISTRIES, INC., Hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of the corporation is, 1811 WASHINGTON AVE., OPA-LOCKA, FLORIDA 33055 MAILING: 1811 WASHINGTON AVE., OPA-LOCKA, FLORIDA 33055

ARTICLE III: DURATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law

ARTCLE V: RESTRICTIONS ON ACTIVITES

No substantial part of the activities of the corporation shall consist of carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on the behalf of (or in opposition to) any candidate for public office.

ARTICLE VI: MEMBERSHIP

The corporation membership shall be established based upon acceptance of a recognized creed and belief and support of the church. With no exceptions based upon; race nationality, background, disability or color.

ARTCLE VII: REISTERED OFFICE AND AGENT

The Corporation's registered office shall be located at 1811 Washington Ave., Opa-Locka, FL. 33055; and DELORES GARNER is the registered agent of the Corporation at that address.

ARTICLE VIII: BOARD OF DIRECTORS

The Board of Directors shall consist of Eight (8) persons.
