

ONE: The name and address of this Principal Corporation is Purpose Insight Counseling and Resource Center, Inc., 4235 Waverly Drive, West Palm Beach, Florida 33407, in Palm Beach County. The Corporation is organized pursuant to the Florida Corporation Code.

TWO: This Corporation is a non-profit public benefit Corporation and is not organized for the private gain of any person. The Corporation is organized under the Non-profit Public Benefit Corporation Law for charitable and educational purposes to aid teenage girls and adult women from ages 12 - 24 towards a life of self-sufficiency. The programs will consist of Economic Development Programs, but shall not be limited to: Homelessness, Health Care, Computer Technology, Child Care, At Risk Youth Tutorial, Land Acquisition, Housing, Job Training and Placement, Mentorship, Counseling, HIV and Sexually Transmitted Disease Awareness, Aftercare Program, Life Changing Seminars, Outreach Advocacy Programs for Students, Literacy, Teenage Pregnancy and Maternal Child Health Services, Prostitution, Runaways, Early Child Development Workshops for Teens, Drowning Prevention Awareness, Assist with Foster Care Kids, Youth Academic and Employment Training, Gang Awareness, Gun Violence Education, Substance Abuse Awareness and Prevention, Food for Families, Family Planning, Homosexually Oriented Peer Empowerment Support, Grief and Loss Collaborative and Family Therapy Solutions, Domestic Violence, Training Dads to be Dads, Training Moms to be Moms, Alcoholic and Drug Awareness.

THREE: The duration of this Corporation shall be perpetual, no stock and have no members.


