

**Articles of Incorporation**

In compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the state of Florida, do hereby certify: 2011 MAR 30 PM 1:44

**Article I:** The name of the Corporation shall be **Deep Water Ministry, Inc.**

**Article II:** The place in this state where the principal office of the Corporation is to be located is 5781 Dove Drive, in the City of Pace, Santa Rosa County, state of Florida.

**Article III:** The purpose of this corporation is to provide religious services to disenfranchised or underserved populations in Santa Rosa County, Florida and Escambia County, Florida. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

**Article IV:** Election of new directors or election of current directors to a second term will occur as the first item of business at the annual meeting of the corporation. Directors will be elected by a majority vote of the current directors.



**Article VIII:** The effective date of these Articles of Incorporation shall be March 25, 2011



Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
