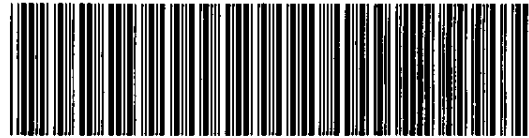

**Articles of Incorporation
Of
The Christopher M. Chestnut Foundation, Incorporated**

Article I

The name of the corporation is the Christopher M. Chestnut Foundation, Incorporated

Article II

The Street Address of the principal office is 5080 Newberry Rd. Suite 2A, Gainesville, FL 32607

Article III

The Corporation is organized pursuant to the Florida Non Profit Corporation Code and is organized exclusively for charitable, educational, and/or scientific purposes under section 501(c)(3) of the Internal Revenue Code.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

We agree that no part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) — any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the internal revenue code, or (b) by a corporation, contributions to which are deductible under 170 (c)(2) of the internal Revenue Code.

Article IV

Directors are appointed, selected or recruited by the board of directors as specified in the organization's bylaws.
