

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

# THE CAPE CORAL PROFESSIONAL FIRE FIGHTERS BENEVOLENT FUND, INC. (Not-for-Profit Corporation)

In compliance with the requirements of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation hereby adopts the following amendments to its Articles of Incorporation:

#### AMENDMENTS ADOPTED

The Articles of Incorporation of The Cape Coral Professional Fire Fighters Benevolent Fund, Inc., are hereby amended as follows:

1. By adding ARTICLE VIII, immediately proceeding ARTICLE VII, which shall read as follows:

This Corporation shall have perpetual existence, however, should this Corporation be dissolved, upon said dissolution assets shall be distributed for one or more exempt purpose within the meaning of Section 501(c)(3) of the Internal Review Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

The day of adoption and the effective date of this amendment was the 19 day of MARCH, 2012.

There are no members entitled to vote on these amendments to the Articles of Incorporation of The Cape Coral Professional Fire Fighters Benevolent Fund, Inc. These amendments were adopted by the Board of Directors.
