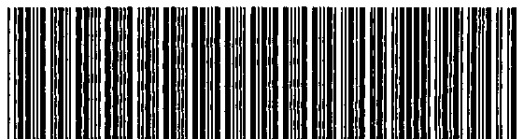

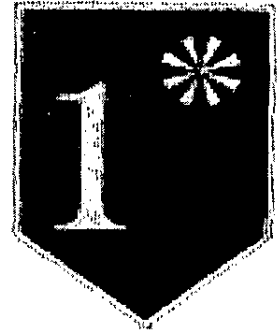



## ARTICLE I: NAME

The name of the corporation shall be:

## ARTICLE II: PRINCIPAL OFFICE

## ARTICLE III: PURPOSE

The purpose for which the corporation is organized:



**ARTICLE VIII: OWNERSHIP**


