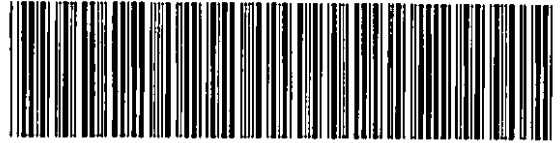

Pursuant to the provisions of Section 617.1006, *Florida Statutes*, the Articles of Incorporation of **SUGAR CREEK MANUFACTURED HOME COMMUNITY, Inc.**, a Florida not for profit corporation (the "Corporation") are hereby amended as follows:

1. The terms of Article I of the Articles of Incorporation are hereby deleted in their entirety and the following is substituted in lieu thereof:

***ARTICLE I**
