Article III of the Articles of Incorporation should be amended to read as follows:

## <u>ARTICLE III</u>

The specific purpose for which this corporation is organized is:

(1) To operate exclusively for charitable and education purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1954, as amended (hereinafter the "Code"); (2) To raise funds for the purposes of the Corporation's function; (3) To develop an organization of local community councils to assist individuals and other organizations in their efforts to create a more harmonious society; (4) To conduct educational programs designed to develop foster the values of non-violence, strong community and empowered youth leadership; (5) To provide one or more forums for the discussion of community values.

Upon the dissolution of the Corporation, whether voluntary or involuntary, the assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
