

AMENDED AND RESTATED ARTICLES OF INCORPORATION

Of

The undersigned hereby submit these Amended and Restated Articles of Incorporation for JERRY THOMAS ELEMENTARY SCHOOL PARENT-TEACHER ORGANIZATION, INC., a Florida Not For Profit Corporation, to supersede the previously filed Articles of Incorporation, and any amendments thereto. These Amended and Restated Articles of Incorporation require member approval and were duly approved and adopted by the Board of Directors pursuant to the provisions of section 617.1006, Florida Statutes, at a meeting held on September 11, 2024.

Article I

The name of the corporation is JERRY THOMAS ELEMENTARY SCHOOL PARENT-TEACHER ORGANIZATION, INC.

Article II

The principal place of business and mailing address is 800 Maplewood Drive, Jupiter, FL US 33458.

Article III

The purpose of this organization is exclusively for charitable and educational purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
