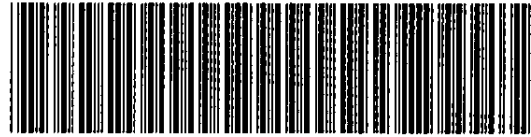

ARTICLE I NAME

The name of the corporation shall be:

CHADD King Systems/Kingham, Inc.

ARTICLE III PURPOSE

The purpose of the corporation is to provide routine care, limited medical assistance and housing for individuals unable to care for their routine needs. This includes physically disabled and not limited to senior citizens.

This corporation is formed exclusively for charitable and educational purposes within the meaning of the section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue Law.

ARTICLE IV BOARD OF DIRECTORS

The By-laws will determine the method of election of each board member, the number of directors and their term of service. Board member qualifications will be stated in the by-laws.

ARTICLE V **DISSOLUTION**

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts, obligations, liabilities; costs and expenses of the corporation, for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.






