# **ARTICLES OF INCORPORATION**

**In compliance with Chapter 617, F.S., (Not for Profit)**

## **ARTICLE I NAME**

The name of the corporation shall be: **Resonate Church, Inc.**

*In the remainder of this document Resonate Church, Inc. shall be referred to as "the corporation."*

## **ARTICLE II PRINCIPAL OFFICE**

**Principal Street and Mailing Address: 38801 Berchfield Rd., Lady Lake, FL 32159**

## **ARTICLE III PURPOSE**

The corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## **ARTICLE IV PROHIBITED ACTIVITIES**

(A) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

(B) No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

(C) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on [1] by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or [2] by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## **ARTICLE V OFFICES AND MANNER OF ELECTION**

The affairs of the corporation shall be managed exclusively by the Resonate Corporate Board (hereinafter referred to as "the board") which shall be composed of the Officers of the corporation and any additional members duly elected to the board according to the bylaws of the corporation. There will not be less than three (3) Officers, including a President, a Vice President and a Secretary. The initial Officers shall be determined by the Articles of Incorporation and, thereafter, the number and manner of election of the Officers shall be fixed in the bylaws of the corporation.

**ARTICLE VII DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. The distribution of assets shall be determined by the most recent Officers of the Resonate Corporate Board. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
