Charter

Articles of Incorporation of Straight Forward Ministries, Inc

The undersigned, a majority of who are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, hereby certify:

First: The name of the corporation shall be Straight Forward Ministries, Inc.

Second: The place in the state where the principal office of the Corporation is to be located, 11520 Kanuba Court, Clermont, Florida 34715.

Third: Said corporation is organized exclusively for charitable, religious, and educational, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)3 of the internal Revenue Code, or the corresponding section of any federal tax code.

Fourth: The officers and directors listed below shall be elected at the annual meeting of committee members by a simple majority vote of those present and voting.

Fifth: The names and addresses of the persons who are the initial officers of the corporation are as follows:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Third Article hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code or the corresponding section of any future federal tax code.

"Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any power that are not in furtherance of the purposes of this corporation.

Sixth: The initial registered agent is James Harrison, 11520 Kanuba Court, Clermont, Florida 34715.

Seventh: The incorporator is James Harrison, 11520 Kanuba Court, Clermont, Florida 34715.

Eighth: Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located exclusively for such purposes to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
