Articles of Incorporation
of
A New Day Outreach, Inc.
(a Florida Not-for-profit Corporation)

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

Article I

The name of the corporation is:
A New Day Outreach, Inc.

Article II

The principal place of business:

Lakeland, Florida 33801

Article III

The specific purpose for which this corporation is organized is to emphasize Christian ministries to the whole community with a special emphasis for seniors and a support system thereunto.

1. The distinctive mission of A New Day Outreach, is to exalt God in our worship and daily life with special emphasis of ministering the love of Jesus Christ to senior citizens while affirming and embracing their spiritual, emotional, and social needs.
2. The general purposes for which this corporation is formed are to operate exclusively for such religious purposes as will qualify it as an exempt organization under Section 501(C)3 of the Internal Revenue Code of 1986, and the corresponding provisions of any subsequent federal tax laws.
3. No part of any income or contribution received by A New Day Outreach shall inure to the benefit of, or be distributable to its members, board of directors, officers or other private persons, except that A New Day Outreach shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the above purpose clause hereof. No substantial part of the activities of A New Day Outreach shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and A New Day Outreach shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, A New Day Outreach shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(C)3 of the Internal Revenue Code, the corresponding section of any future federal tax code, or (b) by an organization,

contributions to which are deductible under section 170(C)2 of the Internal Revenue Code, or a corresponding section of any future federal tax code.

4. Upon dissolution of A New Day Outreach, assets shall be distributed for one or more exempt purposes within the meaning of section 501©3 of the Internal Revenue Code or corresponding section of any future federal tax code to a similarly qualified not-for-profit religious corporation established for the like kind of Christian ministry.
