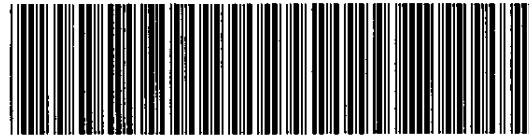

**Article I**

Name

The name of the Corporation is Temple Community and Formation Center, Inc.

**Article II**

Address

The place of business of this organization shall be: 116 Swain Blvd Greenacres, FL 33463

**Article III**

Duration

The corporation shall have perpetual existence.

**Article IV**

Purpose

The objects and purposes for which this Corporation is formed and the powers it may exercise are set forth in the Charter of the Corporations. Its activities shall be exclusively charitable and educational, directed towards providing needed services, food, products, and financial assistance to persons in need and secondarily to facilitate community outreach, affordable housing and community development activities such as but not limited to .education, counseling, crime preventions, health screening, and case management.

**Article V**

Membership

Upon approval by the Board of Directors, any qualified person shall be member of this corporation. This method of election of directors is stated in the bylaws. Membership may be terminated by expulsion for just a cause or resignation with thirty (30) days written notice to the Board of Directors.

**Section 1:** Volunteers, committees, employees and directors of this corporation shall be those persons without regard to race, creed, national origin, political affiliation, or organization who, by action or intent, evidence interest in the welfare of other persons in need, and in purposes of the Corporation.

**Section 2:** At no time shall more than one-third of the membership of the organization's governing board members be public officials or be appointed by public officials.

## **Article VI**

### **Management**

**Section 1.** The Board of Directors shall manage the internal affairs of the Corporation. The Board of Directors shall consist of not less than three (3) and not more than nine (9) persons. The number of directors may be increased or decreased by amendment of these By-laws.

**Section 2.** The officers of the Corporation shall be a President, one or more Vice Presidents and a Secretary/Treasurer. These officers be elected and shall hold office in the manner provided in by the bylaws of the Corporation.

**Section 3. Election of Officers** The Board of Directors will create a Nominating Committee at least 90 days before the annual meeting of the Board of Directors. The Nominating Committee shall consist of two (2) Directors, the president of the board, three (3) other persons, and the Executive Director. The Nominating Committee shall accept and review all nominations to fill the Board seat. After a thorough review of all nominees, the Nominating Committee shall offer one nominee to the Board for each existing Board vacancy. The Nominating Committee shall, at least 30 days before the annual meeting of the Board of Directors, nominate a candidate(s) to serve as a member(s) of the Board of Directors. Thereafter, the following incorporators Samy Chery, Secretary, and Fred Saint-Fleur, the President, whose business address is 116 Swain Blvd Greenacres, FL 33463, both will send a welcome letter to the newly elected board member which include date and time of the next meeting.

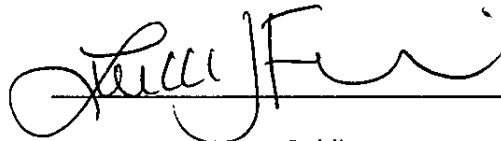

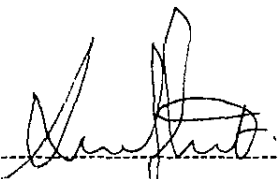
