
**ARTICLE III
PURPOSE**

This corporation is organized exclusively for such nonprofit, charitable and/or educational purposes, and such other purposes as will qualify the corporation as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. More specifically, the purpose of the corporation is to foster low income housing in support of and in conjunction with the vision of the Winter Haven Housing Authority, a public body corporate and politic established pursuant to Chapter 421, Florida Statutes.
