These Articles of Incorporation are hereby made and acknowledged by the undersigned to be filed with the Florida Department of State, for the purpose of forming a corporation not for profit in accordance with Chapter 617 of Florida Statues.

ARTICLE I NAME

The name of the corporation is: Floridians for Patients' Rights, Inc. (the "Corporation").

ARTICLE II PRINCIPAL OFFICE

The principal office address of the Corporation is c/o MG Strategies, 2910 Kerry Forest Parkway, #D4-140, Tallahassee, Florida 32309.

ARTICLE III PURPOSE

The Corporation is formed for the following purposes:

- i. To support good and proper principles and oppose interference in the doctor patient relationship by government in the area of providing medical care to patients;
- ii. To encourage and promote understanding and legal cooperation among patients, health care providers, and payors;
- iii. To support and conform to all laws applicable to patient care; and
- iv. To support and cooperate with appropriate regulatory bodies in all ways in the interest of patients and the public, and to develop, submit, introduce or support any legislation, directly or indirectly, beneficial to patient care, and to vigorously oppose any legislation contrary to the interests of patients or the public.

ARTICLE IV INITIAL DIRECTORS

ARTICLE V MANNER OF ELECTION OF DIRECTORS

The manner by which future directors are to be elected or appointed shall be set forth in the By-Laws of the Corporation. The number of directors may be increased or decreased in the manner provided in the By-Laws of the Corporation, but the Corporation shall always have at least three directors.

ARTICLE VI LIABILITIES OF DIRECTORS

The directors shall be indemnified to the fullest extend that the laws of the State of Florida, as now in effect or as hereafter amended, permit elimination or limitation of the liability of the incorporators, directors and uncompensated officers. No incorporator, director or officer of the Corporation shall be personally liable to the Corporation or its member for monetary damages as such for any action taken, or any failure to take any action, as an incorporator, director, or officer of the Corporation who serves as such at any time while this Article is in effect and each such incorporator, director or officer shall be deemed to be so serving in reliance on the provisions of this Article. Any amendment or repeal of this Article or adoption by any bylaw or provision of these Articles which has the effect of increasing incorporator, director or officer liability, shall operate prospectively only, and shall not affect any action taken, or any failure to act, prior to the adoption of such amendment, repeal, bylaw or provision.
