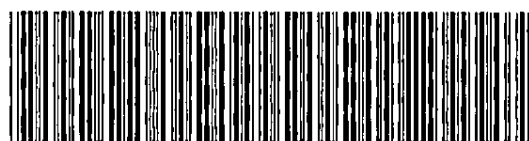

ARTICLE THREE: PURPOSE AND POWERS, Section 1. D. is amended and restated in its entirety to read as follows:

1. D. To operate, maintain and manage the Surface Water or Management System(s),
including all inlets, ditches, swales, culverts, water control structures, retention and detention
areas, ponds, lakes, floodplain compensation areas, wetlands and any associated buffer areas,
and wetland mitigation areas, in a manner consistent with the Southwest Florida Water
Management District Permit requirements and applicable District rules, and to assist in the
enforcement of the Declaration which relate to the Surface Water Management System Facilities.

ARTICLE SEVEN: DISSOLUTION, is amended and restated in its entirety to read as follows:

The Corporation may be dissolved only as provided in the Declaration, By-Laws and by
the Laws of the State of Florida. If the Association is dissolved, the control or
right of access to the property containing the Surface Water Management System Facilities shall
be conveyed or dedicated to an appropriate governmental unit or public unit and that if not
accepted, then the Surface Water Management System Facilities shall be conveyed to a non-
profit corporation similar to the Association.
