ARTICLES OF INCORPORATION
OF

The undersigned acting as incorporators of a corporation pursuant to Florida Corporation Statute 617, adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation shall be:

ARTICLE III

ARTICLE III
PURPOSES

3. To operate exclusively for charitable, religious, and educational purposes within the meaning of section 501 (c) of the United States Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.

ARTICLE IV DISSOLUTION

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors assets of the corporation shall be distributed to a non-profit 501 (c) (3) corporation. " However" if the named recipient is not within existence as a distributee, or unwilling to accept the distribution, the assets shall be distributed to a fund, or foundation, or organization which operates exclusively for purposes specified in section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.

ARTICLE V LIMITATION OF POWERS

Notwithstanding any other provision of these articles , the organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any Future Internal Law.
