



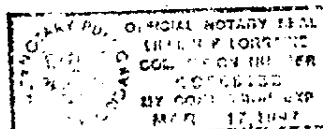

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION

Pursuant to the provision of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: MIRACLES STILL HAPPEN CHURCH, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the corporation:

1. Notwithstanding any other provision of these articles, the purposes for which the organization is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the current Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law.
2. Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the current Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law.
3. In the event dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the current Internal Revenue Code or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

THIRD: The amendments were adopted by the Board of Directors on the 1st day of January, 1995

FOURTH: The above amendments were approved by a majority of the members of the corporation on the 1st day of January, 1995 (5 votes unanimous: all voted yes)

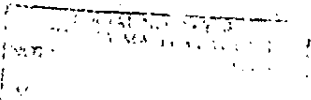
