ARTICLES OF INCORPORATION

THE UNDERSIGNED, desiring to form a corporation not for profit under Chapter 617, Statutes, does ordain and establish these Articles of Incorporation.

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be: Chatonettes, Inc.

ARTICLE II

PRINCIPAL OFFICE AND INCORPORATOR

The initial street address of the principle office of the corporation is 7245 S.W. 130 Pinecrest, Florida 33156, the name of the initial registered agent at the address is Aylin Fraxedas E and the name of the sole incorporator of the corporation at the address is Aylin Fraxedas Ellenburg.

ARTICLE III

PURPOSE

The purposes for which the corporation is organized are as follows:

- (a) To foster, promote and encourage the Miami Palmetto Senior High School Chatonettes dance;
- (b) To fundraise as shall be necessary or desirable to carry out the purposes of the corporation;
- (c) To own, purchase or otherwise acquire such property or services as shall be necessary or desirable to carry out the purposes of the corporation, and;
- (d) To do and perform other acts and functions in furtherance of the purposes hereinabove expressed.

ARTICLE IV

NOT FOR PROFIT

- (a) No part of the earnings of the corporation shall inure to the benefit of any member, officer or officer of the corporation, nor to the benefit of any private individual;

- (b) The corporation shall have no power to act or engage in any act or activity p corporations which are exempt from federal income taxation under Section 501(Internal Revenue Code of 1986 or corresponding Section of any prior or fut Revenue Code;
- (c) In the event of dissolution of the corporation, the residual assets of the corpora turned over to one or more organizations which themselves are exempt from fed taxation as describe in Section 501(c)(6) and 170(c)(2) of the Internal Revenue Cod corresponding Sections of any prior or future Internal Revenue Code, or to the fede state or local government for public purposes exclusively.

ARTICLE V

ELECTION OF OFFICERS AND DIRECTORS

The initial directors of the corporation shall be Aylin Fraxedas Ellenburg and Lisa method of election of officers shall be as stated in the by-laws of the corporation.

ARTICLE VI

AMENDMENTS AND BYLAWS

These Articles of Incorporation may be amended by a two-thirds vote of the members by-laws of the corporation may be adopted by majority vote of the voting members present at a the Board of Directors at which a quorum is present, but the by-laws shall not thereafter amended, or repealed except by a majority vote of the members.

The effective date of this corporation shall be as of the date of filing.


