ARTICLE I: NAME

The name of this nonprofit corporation shall be the American Association of University Women, Venice Branch, Inc. hereinafter called the Branch.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE VII: CONFLICT OF INTEREST POLICY

The standard of behavior at the Branch is that all staff, volunteers, and board members scrupulously avoid conflicts of interest between the interests of the Branch on one hand, and personal, professional, and business interests on the other.

The purpose of this policy is to protect the integrity of the Branch's decision-making process, to enable our constituencies to have confidence in our integrity, and to protect the integrity and reputations of volunteers, members, and the board. Upon or before election, hiring or appointment, a member will

make written disclosure of interests, relationships, and holdings that could potentially result in a conflict of interest. This written disclosure will be kept on file and will be updated as is appropriate. In the course of meetings or activities, members will disclose any interests in a transaction or decision where a business, other nonprofit affiliation, family and/or significant other, employer, or close associates will receive a benefit or gain. After disclosure, the matter will be discussed and reviewed by the board.

ARTICLE VIII: DISSOLUTION

In the event of the dissolution of the Branch, all remaining assets shall be transferred and delivered to a 501(c)3 American Association of University Women entity for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code, or the corresponding section of any future federal tax code. In the event that at the time of dissolution no such entity exists within the America Association of University Women network, all remaining assets shall be transferred to an alternate entity within the meaning of section 501(c)3 of the Internal Revenue Code, or the corresponding section of any future tax code.

ARTICLE X: INITIAL REGISTERED AGENT AND STREET ADDRESS

ARTICLE XII: AMENDMENTS

An amendment to these articles may be proposed by the board of directors or an officer or a member. Amendments shall be adopted by the board of directors by affirmative vote of at least three-fourths of the directors.

ARTICLE XIII: EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers or other private persons, except that the Branch shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III thereof. No substantial part of the activities of the Branch shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Branch shall not participate in, nor intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Branch shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)3 of the Internal Revenue Code, or the corresponding section of any further federal tax code, or (b) by a corporation, contributions to which are tax deductible under section 170(c)2 of the Internal Revenue Code, or the corresponding section of any future federal tax code.
